

Will Belize Electricity compensate you for excess solar energy?

The hope is that through regulations, Belize Electricity Ltd will have to compensate you for excess solar energy flowing to the grid during the day and off-set it against the electricity you are drawing from the grid at night; however, the reality today is the opposite.

Does Belize use solar power?

Belize uses solar power on a smaller scale, with the Government having installed solar micro-grids and solar-powered streetlights in rural communities not yet connected to the national grid. The Government of Belize, along with Belize Electricity Limited (BEL), intends to launch a pilot project introducing electric vehicles.

How much does electricity cost in Belize?

Belize's utility rates are approximately \$0.22 per kilowatt-hour (kWh), lower than the Caribbean regional average of \$0.33/kWh because of existing renewable energy projects, but still high compared with U.S. mainland rates.

What is net metering? When a solar panel system is installed, solar energy is either used by your home or exported into the grid. You'll want to make sure you're compensated for the energy you export. A net meter is a device that measures the amount of solar energy your household or business exports, as well as the amount of electricity you import from the grid.

With solar net metering, the homeowner is only billed for the "net" energy used each month, that is the difference between the energy produced by the solar power system and the energy consumed by the house or the business over the monthly billing period. When your house or business is net-metered, depending upon
