

Breach of contract for photovoltaic panels on roof

What are the construction issues relating to solar PV installations?

The key issue for solar developments is visual impact and glare. For those looking at procuring their own systems, it is worth briefly touching on some of the construction issues that relate to solar PV installations. Who leases roof space for a solar PV system?

The building owner (the landlord) leases roof space to the developer of the PV system (the developer). The developer purchases the solar PV system (the equipment) and procures its installation. There may be an occupational tenant (the tenant) already leasing the building from the landlord (more details on this below).

Are solar panels a split construction contract?

Solar contracts for rooftop spaces are typically turnkey contracts rather than split construction contracts; however, there may be a situation where the company considering an installation procures the panels itself and asks an installer to fit them. Some key areas of construction risk include:
