

Is China revoking antidumping duty on crystalline silicon photovoltaic cells?

The Department of Commerce (Commerce) is revoking, in part, the antidumping duty (AD) and countervailing duty (CVD) orders on crystalline silicon photovoltaic cells, whether or not assembled into modules (solar cells), from the People's Republic of China (China) with respect to certain off-grid...

Can Chinese solar panels be made outside China?

Thus, while the existing China antidumping and countervailing duty orders still significantly restrict imports made using Chinese solar panel parts and components, it is possible for companies outside of China to manufacture products using Chinese components, provided that they follow the four-component rule.

Did China win a comprehensive victory in anti-dumping investigations initiated by Australia?

It is the second time that the Chinese PV Solar Industry won a comprehensive victory in the Anti-Dumping investigations initiated by Australia. Australia initiated the Anti-Dumping investigation for the PV Solar Product exported from P. R. China on 14 May 2014.

Are Chinese-owned solar panels avoiding Chinese tariffs?

According to the U.S. solar industry, Chinese-owned solar manufacturers have been circumventing preexisting tariffs on Chinese products by routing their solar panels to Southeast-Asian facilities in other countries for minor processing and then claiming the products are no longer Chinese in origin.

What are crystalline silicon photovoltaic cells?

Also excluded from the scope of these investigations are crystalline silicon photovoltaic cells, not exceeding 10,000mm² in surface area, that are permanently integrated into a consumer good whose function is other than power generation and that consumes the electricity generated by the integrated crystalline silicon photovoltaic cell.

Is there a loophole against solar manufacturers in Cambodia?
