

Will France be able to develop solar power in 2023?

Several legal routes have been activated by the French government to accelerate the expansion and development of solar power in France. France is currently on course to miss its target to commission 20.1GW of solar power by late 2023.

Holosolis plans to build its facility in Hambach, near Sarreguemines, northwestern France.
