

# Does Australia have anti-dumping measures for photovoltaic panels

How does the anti-dumping system work in Australia?

The anti-dumping system addresses the importation of goods dumped into Australia. This is where goods are sold to Australia, below their normal value. The sale price is usually subsidised or is the market price in the country of manufacture and can cause material injury to Australian industry.

How do I apply for a dumping exemption in Australia?

Australian industry members, importers and exporters can apply for a review or exemption of dumping or countervailing duties. The Anti-Dumping Commission's current cases is listed on the Electronic Public Register. You may also apply to the Anti-Dumping Commission for a final duty assessment within a specific timeframe.

What does the Anti-Dumping Review Panel (ADRP) do?

It investigates claims that anti-dumping measures are required, and runs other related activities. The Anti-Dumping Review Panel (ADRP) reviews, upon application, certain decisions made by the minister or by the Commissioner. The ITRA Service is not part of the commission or the ADRP and does not act on their behalf.

Did China win a comprehensive victory in anti-dumping investigations initiated by Australia?

It is the second time that the Chinese PV Solar Industry won a comprehensive victory in the Anti-Dumping investigations initiated by Australia. Australia initiated the Anti-Dumping investigation for the PV Solar Product exported from P. R. China on 14 May 2014.

Are dumping and countervailing duties still imposed in Australia?

In some cases duty payable may be more than the value of the goods. Dumping and countervailing duties still apply to goods imported from countries with which Australia has free trade agreements. Anti-dumping and countervailing measures are imposed where Australian manufacturers are being materially injured by dumped or subsidised imports.
