

What is Kosovo Energy Security of supply?

Will Kosovo become a leader in the energy sector?

By implementing the largest BESS installation in the region, Kosovo will become a leader in the field, surpassing other countries in the area and beyond. The project, co-funded by the Government of Kosovo and MCC, aims to build a 340 MWh BESS installation by 2027. The project is expected to bring significant benefits to the energy sector in Kosovo.

Which companies are affecting the energy sector in Kosovo?

Besides government institutions, there are also companies with great impact in energy sector such as Kosovo Energy Corporation (KEK), Transmission, System and Market Operator (KOSTT) and Kosovo Electricity Distribution and Supply (KEDS). The government of Kosovo will build a battery energy storage system (BESS) with a capacity of 200MWh-plus to deal with the energy crisis.

What is the energy strategy for Kosovo?

The Kosovo energy strategy includes increasing RES capacity to 35% of electricity consumption by 2031. Aiming for 600 MW wind, 600 MW solar PV, 20 MW biomass & at least 100 MW of prosumer capacity, to reach a total installed RES capacity of 1600 MW by 2031. Lignite exploitation in Kosovo started in 1922.

Who regulates the energy sector in Kosovo?

Regulation of activities in energy sector in Kosovo is a responsibility of the Energy Regulatory Office (ERO). An additional factor in the energy sector in Kosovo is Ministry of Economic Development (MZHE), which has the responsibility of dealing with issues that have to do with energy. MZHE prepares legislation and drafts strategies and projects.
