

Is Cayman the perfect place to harness solar energy?

What is the first commercial solar project in Cayman?

The 20 acre 5MW Solar Farm located in Bodden Town is the first commercial solar project in Cayman. Completed in 2017, this solar farm was also the first Independent Power Producer (IPP) in Grand Cayman, selling electricity to CUC through a Power Purchase Agreement (PPA).

The German Federal Network Agency (Bundesnetzagentur) has awarded 587MW of solar-plus-storage in its latest Innovation Tender. As has been the case in many of Germany's recent solar PV auctions, the Innovation Tender ended up oversubscribed, with 154 bids made for 1.8GW of capacity out of 583MW tendered capacity.

The German government enacted the first technical regulations for plug-in solar devices in 2019, allowing balcony solar systems to use standard electrical plugs and feed into the grid. That prompted an influx of plug-in devices and advocates to promote the technology.

Germany has capitalised on solar PV's growth. According to GlobalData, in 2014, solar PV made up 20% of its power mix, with fossil fuels (coal, oil and gas) dominating at 43% and wind at 21%. In 2023, solar PV surpassed fossil fuels, accounting for 33% of power capacity compared to the latter's 30% and 28% for wind.
