As per the solar rooftop scheme in MP, the government provides subsidies on L1 rates. L1 is the lowest bid that a vendor places on the solar panels in the state's subsidy tender. For 1 KW to 3 KW = the solar subsidy in MP is 40% on L1 prices. For more than 3 KW (up to 10 KW) = the subsidy on solar panel in MP is 20% on L1 prices.
