Should I claim back my energy bill if I owe £70?

Before claiming back any money, think about: If the amount you're owed is more than the amount you pay as a monthly direct debit, you might want to claim back the difference. Your August bill shows that your account is £70 in credit after paying for energy for that month. Your next monthly direct debit is £40.

How do I get a refund on my energy bill?
