

How do I Register energy devices?

Guidance for device owners and installers on how to register energy devices, including heat pumps and electric vehicle charge points. You must register the following energy devices with your local Distribution Network Operator: This document tells you what your responsibilities are and when you need to notify the Distribution Network Operator.

What is a solar generation meter?

The solar generation meter is an AC device which draws its power from the mains, at night or when the solar system isn't generating the red light will stay on (not flashing) and you will be able to read the generation figures on the display.

How do licensed electricity suppliers use the Register?

How much documentation do I need for a solar generator?

The documentation required depends on the size of the solar generator. Generally, the larger the system, the more forms you'll need to fill out before installation. For solar power systems, the threshold is typically 16 amps per phase. The inverter's AC output helps determine your rated amp output.

How long does it take to register an energy device?

If MCS certified, the installation contractor must register the energy device with MCS's Microgeneration Installation Database (MID) within 10 days of installation. If TrustMark registered, and work is funded by certain energy efficiency schemes, the installation contractor must register the installation in the TrustMark Data Warehouse.

Who should I contact if I have a solar installation?

If you have an installation which is solar photovoltaic (PV) or wind with a Declared Net Capacity (DNC) of 50kW or less (e.g. you're a homeowner with solar panels on your roof) you should contact your FIT Licensee.
