

Who is Drax Group plc?

Drax Group plc, trading as Drax, is a power generation business. The principal downstream enterprises are based in the UK and include Drax Power Limited, which runs the biomass fuelled Drax power station, near Selby in North Yorkshire. The Group also runs an international biomass supply chain business.

Who uses Drax power?

Drax supplies renewable source power to over 165,000 businesses and organisations across the UK, including electricity from Drax Power Station. We provide and manage electricity for large industrial and commercial sector customers from our offices in Northampton and Ipswich. Opus Energy

What is Drax Power Station?

It is the most advanced and efficient coal-fired power station ever built in the UK. Drax Power Station is officially opened with three generators and a total electrical capacity of just under 2 gigawatts (GW). It has the capability to power around two million homes.

What happened at Drax Power Station in North Yorkshire?

In April, Drax announced the official end of coal-fired generation at Drax Power Station in North Yorkshire, marking a historic milestone in both the company and the UK's transformation to a zero-carbon energy future.

Did Drax buy Opus Energy?

In 2016, Drax Group acquired Opus Energy for £340 million funded by a new acquisition debt facility of up to £375 million. In October 2017, Drax sold Billington Bioenergy for £2 million to an AIM-listed energy company called Aggregated Micro Power Holdings.

Is Drax power station compliant with LCPD?

Drax Power Station undergoes refinancing and Drax Group plc is listed on the London Stock Exchange. Boosted-over-fire-air (BOFA) technology is retrofitted to all boilers and emissions of nitrous oxide (NO_x) are reduced ensuring Drax Power Station is compliant with a strengthened Large Combustion Plant Directive (LCPD).

On 31 May 2023, Ofgem opened an investigation into whether Drax Power Limited ("Drax") was in breach of annual profiling reporting requirements relating to the Renewables Obligations ("RO") scheme and other related matters.
