

# Tariffs on photovoltaic panels imported into China

What if China imposes new solar tariffs on imports from Southeast Asia?

When the presidential moratorium on new solar tariffs on imports from Southeast Asia expires next June , imports of solar cells and modules from these five companies will be subject to the tariffs faced by Chinese solar manufacturers, with the tariff level ranging from 50 percent to 250 percent of the import value.

What are solar panel import tariffs?

Solar panel import tariffs are primarily intended to support the development of a new U.S.-based solar module manufacturing supply chain, which is financially backed by the Inflation Reduction Act. This act introduces a series of tax credits designed to bolster domestic manufacturers. For solar modules, the credits are as follows:

Are Chinese companies skirting US tariffs on Chinese and Taiwanese solar panels?

Auxin Solar, a small California-based solar panel manufacturing company, petitioned the US government, arguing that Chinese companies are skirting US tariffs on Chinese and Taiwanese solar cells and modules by effectively routing equipment through countries in Southeast Asia that are not subject to the same tariffs.

Are Chinese solar companies dodging US tariffs?

The Commerce probe found that units of Chinese companies BYD (002594.SZ), Trina Solar (688599.SS), Vina Solar (601012.SS) and Canadian Solar (CSIQ.O) were dodging U.S. tariffs on Chinese solar cells and panels by conducting minor processing to finish their products in Cambodia, Malaysia, Thailand and Vietnam before shipping them to the U.S. market.

Did Obama impose tariffs on Chinese solar panels?

Recent US presidential administrations from both parties have levied tariffs on imported solar panels. In 2012, the Obama administration imposed tariffs on Chinese solar manufacturers under anti-dumping and countervailing duty (AD/CVD) laws.

Will Biden increase US import tariffs on Chinese solar panels?

Last week, President Biden announced plans to increase U.S import tariffs on Chinese solar cells and panels from 25% to 50% among a host of other products, on the grounds of unfair Chinese business practices.

On September 13, 2024, the United States Trade Representative (USTR) announced the final Section 301 tariff increases on imports from China, following its original proposal in May ...

The Biden administration has also decided to raise tariff rates on aluminum and steel imported from China, from 0% to 7.5% up to 25%, as well as those applied to semiconductors, from 25% to 50%.
